1st Deposit: A deposit of 10% of Total Tuition is due upon signing a contract.

2nd Deposit: An additional deposit of 10% of Total Tuition is due on May 15, 2010.

Payment Option A: Payment of the balance is due on June 15, 2010.

Payment Option B: Payment of the balance is due in two equal payments on June 15 and November 15, 2010, and this option includes a 3% service fee.

Payment Option C: Payment of the balance is due in ten (10) monthly installments starting on June 15, 2010 and ending on March 15, 2011, and this option includes a 6% service fee.

After School Sibling Discount: If two siblings attend the same After School program, there is a 5% discount for both children. If three or more siblings attend the same After School program, there is a 10% discount for each child.

Parent Teacher Student Association (PTSA): The FCM PTSA is responsible for organizing events throughout the year, which bring the community together, and for organizing volunteer activities at FCM. The following fees, which are optional, are collected in order to facilitate these events and activities.

- **Family Fee: \$40** - An annual fee per family, which funds FCM community events.
- **Classroom Fund: \$15/child** - The room parents for each classroom use the money for classroom projects, for gifts for the classroom teachers and/or classroom gifts.

Field Trip Fees: Each classroom takes various field trips (art museums, music performances, campouts, and other opportunities) while third year Lower Elementary students also travel to Washington DC. Upper Elementary trips are done on a rotating basis with widely divergent costs; therefore, the fee will be determined after classes begin. All fees are due on June 15, 2010 with the exception of Third Year Trip Fee which is due February 1, 2011. The UE fee schedule will be determined after classes begin.

New Family Fee: One-time fee of \$1,000, paid by each new family (once per family) at the same time as the tuition deposit.
